#### **1 Project Description**

Eskom is in the process of expanding their power supply grid by supplying additional substations to areas in need of additional capacity and supplying electricity to areas with increasing electricity demand in the North West and Gauteng Province.

The proposed project includes the construction of a substation in Cashan and a 9 km powerline to the existing Hekpoort substation. The proposed Cashan substation falls within the Gauteng province, North West of Krugersdorp and is intended to alleviate the pressure exerted on the existing Eskom infrastructure in the area. The proposed Cashan substation will be connected to the existing Hekpoort substation via a 88kv powerline which runs approximately 9 km in a North Easterly direction from Cashan into the North West Province.
