Occupiers of the directly affected land and occupiers of adjacent land parcels are scattered over large areas and closer to the proposed Cashan substation a large number of occupiers fall within the notification area. The written notification required by GN R 543 (54)(2)(b)(i) and (iii) are therefore neither feasible nor reasonable.
