Notification of Varied Atmospheric Emission Licenses

We would like to inform all stakeholders who participated in the process in respect of Sasol's postponement applications, for its operations in Secunda, Ekandustria and Sasolburg, that Sasol's applicable atmospheric emission licenses ("AELs") for Secunda and Sasolburg have recently been varied to reflect the postponement decisions where extended compliance time frames were granted by the National Air Quality Officer. Sasol was not granted extended compliance time frames for its Ekandustria operations and hence this existing AEL has not been varied.

This serves as a formal written notification, as required by conditions of these AELs, to all registered interested and affected parties, of Sasol's receipt of these varied AELs.

Varied Atmospheric Licenses issued by the licensing authorities

Sasol's operations in Secunda and Sasolburg are conducted in accordance with AELs that were initially issued by the local licensing authorities in March 2014. The postponement decisions referred to above, required the applicable AELs to be amended, varied and for additions to be included by the local licensing authorities as necessary, to reflect the postponement decisions therein for them to have force and effect.

The Fezile Dabi District Municipality issued and amended AEL for Sasol's Sasolburg operations on 30 March 2015 and the Gert Sibande Municipality issued an amended AEL for Sasol's Secunda operations on 31 March 2015.

In terms of condition 10.2 of the Sasolburg AEL, there was an appeal procedure provided for in Chapter 7 of GN No R543 of 18 June 2010. According to condition 10.3 of the AEL, appeals against the decisions contained in the AELs must be lodged in writing to the Director: Environmental Health and Emergency Services, Fezile Dabi District Municipality, PO Box 10, Sasolburg, 1949, Tel No:016 970 8600, Fax No:016 973 1582.

With regards to the Secunda AEL, condition 10.2 explains that there is an appeal procedure provided for in section 43 of the National Environmental Management Act, 107 of 1998 ("NEMA"), as amended. According to condition 10.3, an appeal against the Secunda AEL decision must be lodged in terms of section 43 of NEMA from the date of this.
