### INTRODUCTION

The purpose of this document is to provide stakeholders with the following:

- Information on the background to Natref's application for postponement from certain of the requirements of the List of activities which result in atmospheric emissions which have or may have a significant detrimental effect on the environment, including health, social conditions, economic conditions, ecological conditions or cultural heritage published under Government Notice No. 248, Gazette No. 33064 dated 31 March 2010, in terms of section 21(1)(b) of NEM:AQA, and in particular Part 3 of the schedule, the Minimum Emissions Standards (the MES).
- An outline of the legal framework governing air quality management in South Africa and specifically the MES pertinent to this BID and related applications.
- Information on the public participation and application process that will be followed.
- Information regarding opportunities to provide comments relating to this application.



### BACKGROUND

Natref is South Africa's only inland crude oil refinery which refines various grades of crude oil. Natref is located in Sasolburg in the Metsimaholo Local Municipality which forms part of the Fezile Dabi District Municipality in the Free State Province.

Natref's approach to air quality management is well aligned with the risk-based philosophy adopted by

the ambient air quality standards.

Natref has prepared dispersion model scenarios to understand its impact on ambient air quality in the region in which it operates and its capacity to improve these outcomes with emission reduction technologies. This is contextualised against the backdrop of other sources of ambient air pollution, to identify the most effective actions to achieve ambient air quality improvements. This approach helps to inform Natref's air quality management priorities, by identifying the key actions to improve ambient air quality effectively.

Natref remains committed to meeting its commitments agreed to in the Vaal Triangle Priority Area Air Quality Management Plan.

To this end Natref is progressing its air quality improvement roadmaps by implementing applicable projects in the priority area. Natref provides regular updates to its local licensing authority as well as the national authority in this regard. These commitments include a reduction in emission of Particulate Matter, Volatile Organic Compounds and Sulphur Dioxide.

## LEGAL REQUIREMENTS

### AIR QUALITY MANAGEMENT

The term “ambient air quality” refers to the state of the air in our surrounding environment. Good air quality is important not only for humans, but for other organisms and the environment in general. Poor air quality is a result of many factors, including emissions from various sources, both natural (such as veld fires) and human-induced (industrial and domestic emissions).

The role of the regulatory authorities is to ensure that ambient air quality meets standards set to protect human health and the environment. To achieve this, the Department of Environmental Affairs has promulgated two related but distinct standards. The first are referred to as point source emission standards (also called Minimum Emission Standards (MES)), which place limits on the concentration of emissions from certain industrial activities. The second are ambient air quality standards which seek to set total emissions from all contributors (i.e. industry, citizens and natural causes) to a level that protects human health and the environment.



NEM:AQA provides for various specific air quality management measures. These include the declaration of priority areas such as the Vaal Triangle Airshed Priority Area and the Highveld Priority Area; ambient air quality standards and point source emission standards as regulated in the MES. The MES prescribes the limits for point source emissions from existing plants which became effective from 1 April 2015 (the so-called ‘existing plant standards’), as well as more stringent limits that must be met by 1 April 2020 (the so-called ‘new plant standards’) (termed “Compliance Timeframes”). Part 2 of the MES allows for applications for postponements to the prescribed compliance timeframes. Postponement applications must be made to the National Air Quality Officer at the Department of Environmental Affairs.

As part of an application for postponement, Natref is required to submit an Atmospheric Impact Report (AIR) and detailed justification and reasons for the postponement request. The MES also require that Natref make these documents available for public comment as prescribed in Chapter 6 of the Environmental Impact Assessment (EIA) Regulations GN R326 (2017) promulgated under the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA).

### NATREF’S APPLICATION

Natref operates various processes that require an Atmospheric Emission Licence (AEL), some comply with the MES and some have previously been granted postponement by the National Air Quality Officer (NAQO), with the concurrence of its licensing officer. Natref is however challenged to meet the 2020 new plant standard (outside of the Turnaround and Inspection shutdown period) applicable to the availability requirements of the Sulphur Recovery Unit, under sub-category 2.3 of the MES. Natref therefore intends to seek postponement with regards to the availability requirements of the Sulphur Recovery Unit in terms of Sub-category 2.3 of the MES.



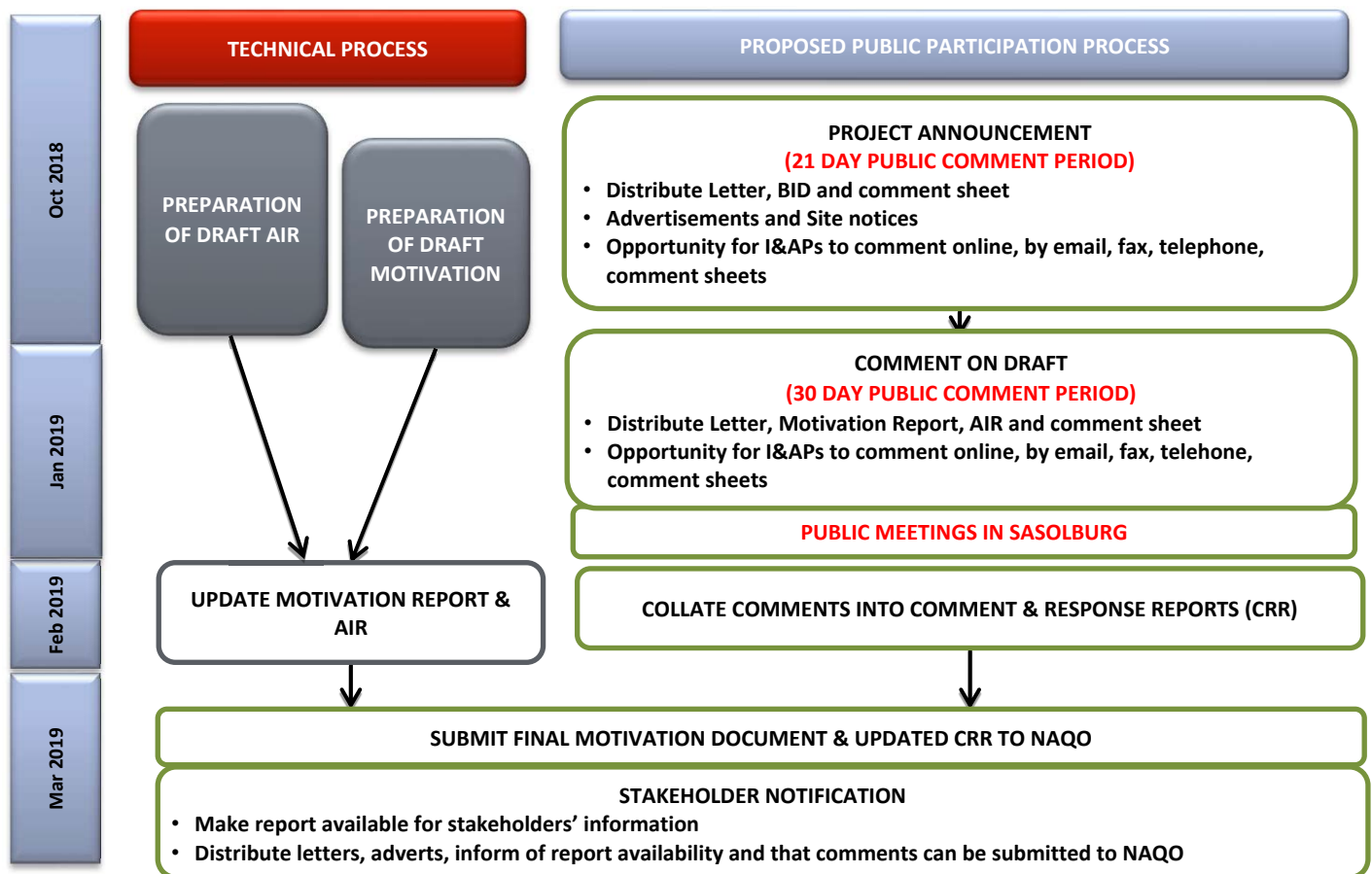
## APPLICATION PROCESS

Natref has appointed a team of independent specialists to assist with the application. SRK Consulting (South Africa) (Pty) Ltd (SRK) has been appointed to undertake the public participation process and to assist Natref in compiling the Motivation Report. Airshed Planning Professionals (Pty) Ltd (Airshed) has been appointed to prepare the Atmospheric Impact Report (AIR). Natref has also appointed Exponent to peer review the air dispersion modelling approach.

The AIR, will detail Natref's impact on ambient air quality in the areas affected by its operations in Sasolburg. The Motivation Report will be informed by the AIR as required in terms of Part 2 of the MES. It will further detail the reasons and justification for the postponement application and outline the steps to be taken by Natref to achieve compliance.

Natref is committed to affording I&AP's the opportunity to provide their comments during the public participation process. This process has been informed by the requirements for consultation in terms of the 2017 Amended EIA Regulations. Responses to comments received during the stakeholder engagement process will be submitted together with the Motivation Report to the authority for consideration during decision making.

The proposed technical and public participation activities, as well as the broad timeframes for roll out of these processes are shown in the flow chart below.

# Applying for government jobs made easier online

Job seekers will soon be able to apply for government jobs through the e-Recruitment system that was launched by Public Service and Administration Minister Ayanda Dlodlo. Addressing the launch on Wednesday, the Minister said the e-Recruitment system is being phased in starting with the Department of Public Service and Administration (DPSA), which is expected to go live on Wednesday and it will be speedily rolled out to the whole public service.

"The e-Recruitment system is part of a government-wide process to make it simpler and easier for people, especially the youth, to apply for job opportunities in the public service. "The process will also include a review of regulations for all entry level posts in the public service to allow the recruitment of new entrants without prior experience into entry level jobs," Dlodlo said.

She said it is indisputable that the current recruitment processes are cumbersome for job-seekers and government departments have not moved or evolved with the changing technological advancements. "For job-seekers, the new e-Recruitment system will be beneficial because it is web based and accessible from different locations for all job seekers who submit applications to a centralised database," she said.

The Minister said the system will enable the applicants to post their CVs and supporting documents once and the process will save them the cost of making multiple copies for applications. "It is important to stress that applications for jobs in the Public Service will still be accepted through the physical Z83 forms to accommodate those who do not have access to the internet and will also be available in an online digital for-

mat to allow for a quick and easy application process for those who have internet," she said.

The Minister said a benefit for government departments is that the system allows them to advertise posts electronically and therefore reduces the cost of current methods of advertising in newspapers. This innovative process is a collaborative effort between the Department of Public Service and Administration and the Gauteng Department of e-Government.

The Gauteng Department of e-Government provides the required resources to operate the system, while the State Information Technology Agency is partnering on the provision of technical and infrastructure development skills. "Through the launch of e-Recruitment, as government, we demonstrate our commitment to uplifting the lives of our people, especially the youth and graduates.

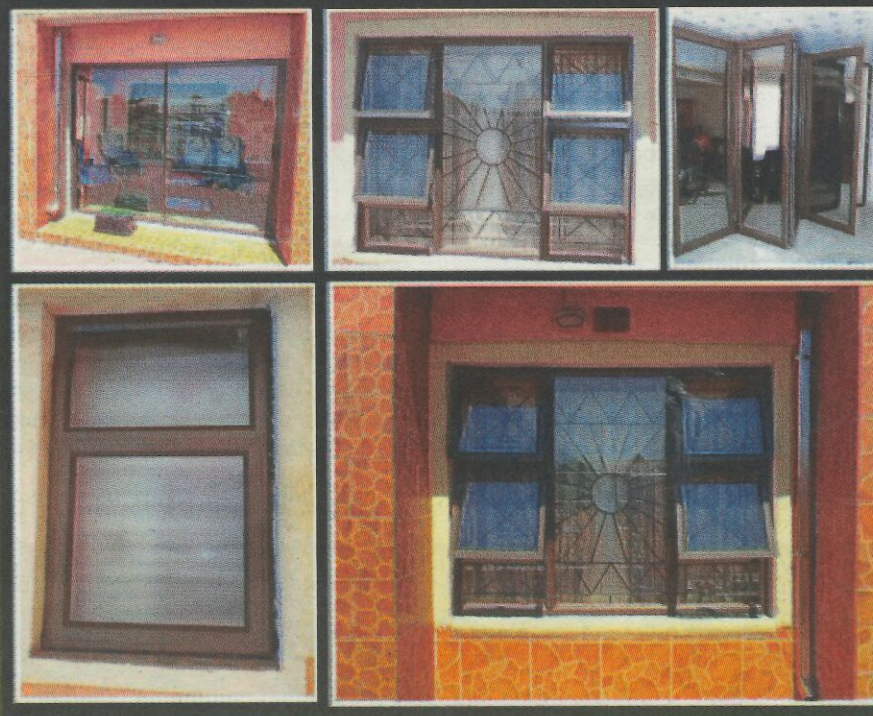

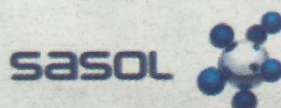

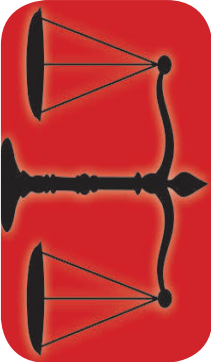

# President commends Matric Class of 2018

President Cyril Ramaphosa has congratulated the Matric Class of 2018 for keeping the National Senior Certificate (NSC) pass rate above 70%. The President said this achievement underscores the importance of learners, educators, families, administrators and political leadership working together. The matric class of 2018, who sat for the NSC examination, achieved a 78.2% pass rate. The pass rate, which is inclusive of the progressed learners, is a 3.1% improvement from the 75.1% achieved in 2017.

“As South Africans, we can all take pride in the dedication shown by learners and educators. Together, they have presented our nation with another cohort of young people whose life chances have been significantly enhanced, and whose success in basic education is indeed reversing the damage inflicted on generations of South Africans who were deprived of quality education under apartheid,” said President Ramaphosa.

The Class of 2018 was the fourth large cohort in the history of basic education to register for any NSC examination. President Ramaphosa said this illustrated the impact of government's support to poor learners and their families. This support spans pro-poor funding of schools; the provision of nutritious meals on a daily basis; and the provision of scholar transport to deserving learners on daily basis. These interventions have led to increased levels of retention of learners and enabled their success in the National Senior Certificate examinations. The President has urged matriculants to show responsibility in exploring opportunities in higher education, vocational training or workplace experience, and to adopt the understanding that learning is and should be a lifelong endeavour. President Ramaphosa has also encouraged learners who did not pass to make use of Second Chance programmes and to believe in their ability to overcome this challenge as one of many that will bring out the best in them during the course of their lives.

# NSFAS will no longer communicate via SMS

The National Student Financial Aid Scheme (NSFAS) has announced it will no longer communicate directly with students via SMS during the 2019 academic year. The decision, said NSFAS in a statement on Thursday, was effective immediately. The student financial aid scheme said it has also advised students to only use the myNSFAS online self-service portal to view application status or any other information relating to funding. The move came after the scheme was over the past two weeks targeted in phishing email and text message scams that aim to compromise personal data. “NSFAS identified scams in which fraudsters lure students into providing confidential information via a link to a site controlled by the attackers. The email or text message scam is designed to look like it is a regular message issued by the NSFAS contact centre,” said the scheme in the statement.

NSFAS said the unidentified attackers are posing as NSFAS representatives and sending out emails requesting applicants and progressing students to update their account information by clicking on an embedded link. “We would like to warn all the applicants, students and parents to be aware of these fraudsters and take extra care when dealing with their personal information online or over the phone. Any SMS messaging regarding funding received following this message will be from fraudsters and not NSFAS,” the scheme said.

NSFAS administrator Dr Randall Carolissen said the scheme was seeing an increase in fraudulent activities, possibly due to the increase in the number of applications for 2019. “We advise every student that NSFAS will never ask for your account details, password, PIN or OTP over the phone or via email,” he said. “Henceforth, NSFAS will only communicate with applicants and progressing students via the myNSFAS Online Self-Service Portal or via the NSFAS Contact Centre. Call Centre Agents will ensure that suitable precautions are being taken and key security questions are asked to positively identify the person contacted and to build trust.

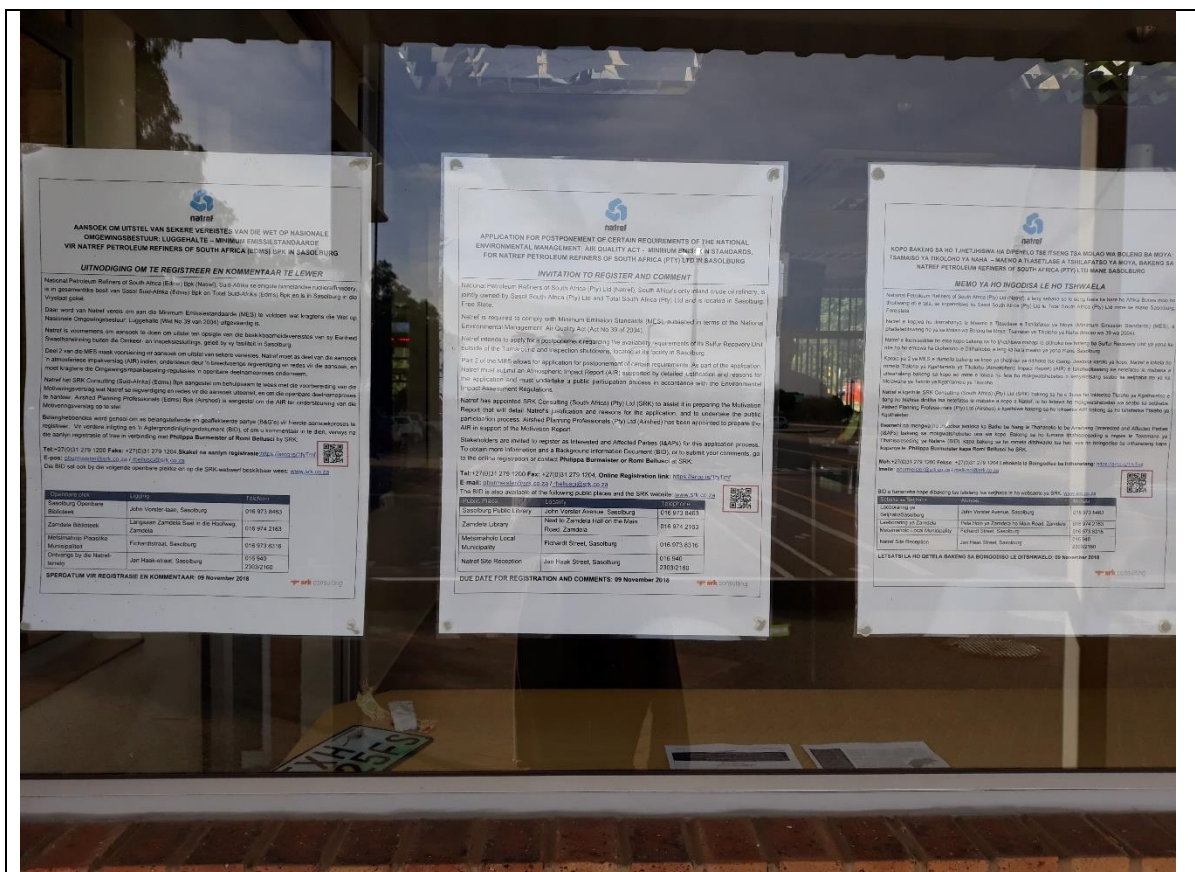


Figure 1: Site notices placed at Natref Site

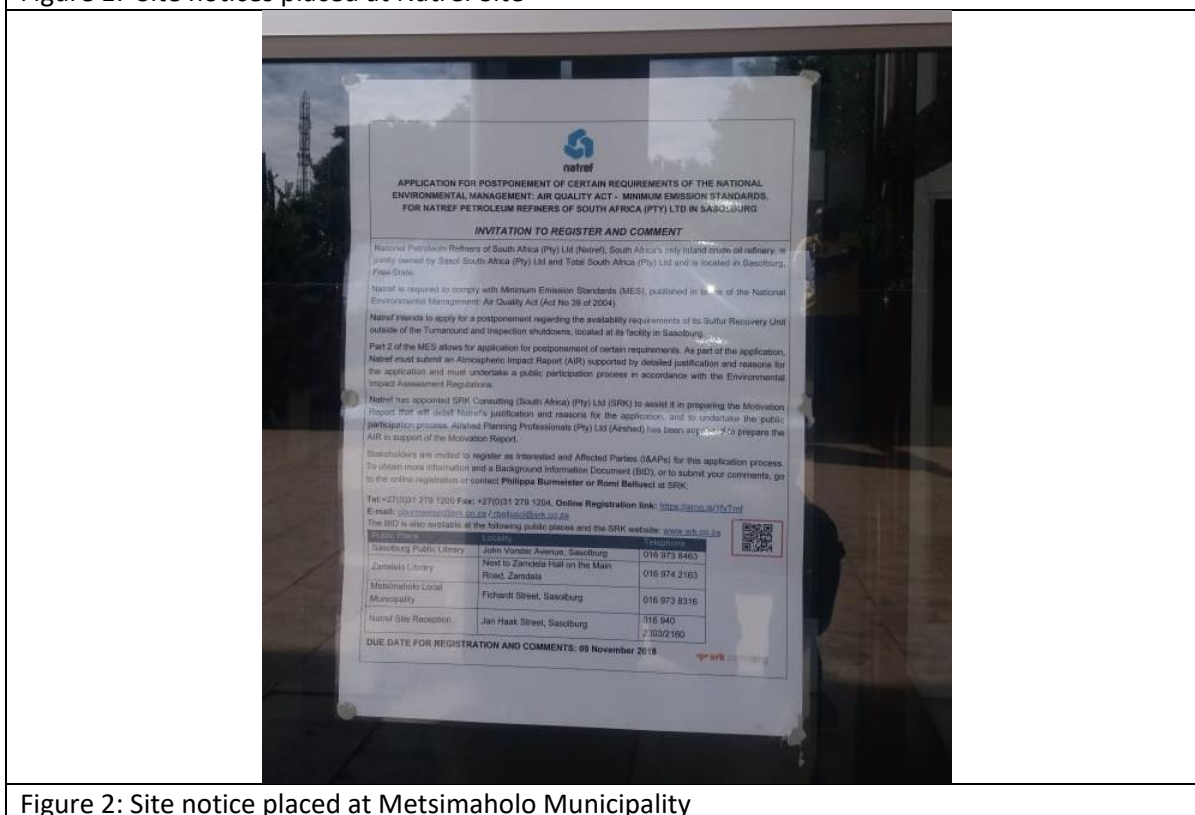


Figure 2: Site notice placed at Metsimaholo Municipality



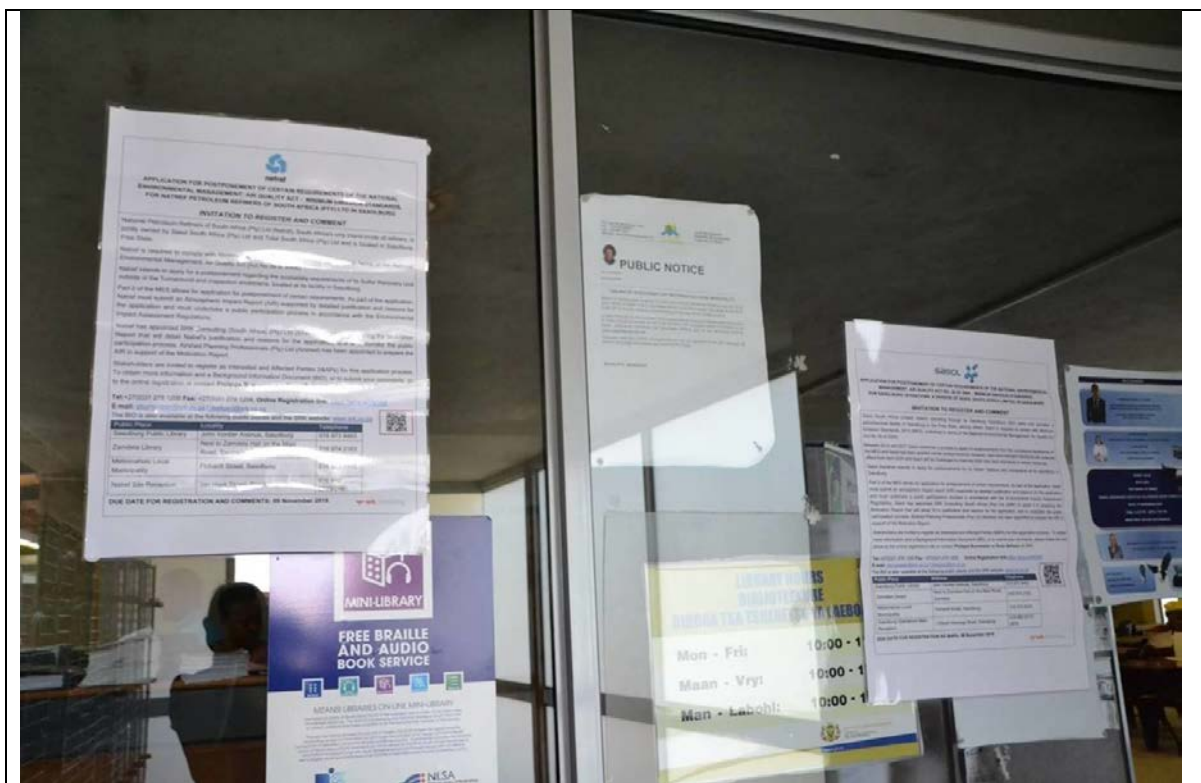


Figure 3: Zamdela Public Library
