Once again, apologies for the delay. Please see responses to your queries below in red.

1. According to your Draft Scoping Report all the existing buildings, stacks and chimneys will be demolished and replaced as per the plan on the same report. This plan depicts a new stack/chimney, we would like to know what is the height of this proposed stack/chimney and what is the height of the existing stack/chimney.

The engine house to be constructed will consist of silencers (45 dBA) and exhaust stacks with 33 m height.

- 2. The surrounding air space is utilised for manoeuvring aircraft to and from the airport, we would like to know if the stacks will emanate any clouds of gas, steam, flame, smoke or any other vapours that will hinder visibility in the area; An Atmospheric Impact Report was undertaken as a specialist study for the required environmental applications on behalf of Newcastle Energy for the proposed project. This assessment accounts for all significant air pollution releases associated with operation of the new 100 MW NGEPP i.e. Nitrogen Dioxide (NO2), Carbon Monoxide (CO), Particulate Matter (PM10) and Nonmethane hydrocarbons (NMHC). The burning of clean natural gas produces insignificant levels of these which are well below the National Ambient Air Quality Standards (NAAQS). Furthermore, these gases are colourless and odourless meaning that they would not impede on visibility in any way. The only anticipated smoke from the stacks is during a cold start of the plant using either Light Fuel Oil (LFO) or Heavy Fuel Oil (HFO). This is very brief until the facility achieves optimum operating temperature.
- 3. Is there any further infrastructure that will be connected to the site for the distribution of electricity produced.

  Yes. At this stage, Newcastle Energy proposes to increase its electricity generation capacity within the existing site from 18MW to approximately 100 MW. Once the expansion is complete, they propose to construct a powerline which will begin at the power plant and extend approximately 7km (straight line distance) North of the site to the existing Ncandu/Signal Hill substation. However, this is outside of the current scope of work for which we are making this application for an approval letter to the Municipality. The powerline application is separate from the power plant application.

Thank you for the breakthrough. We have been in contact with the Civil Aviation Authority (CAA) regarding an obstacle application for a proposed gas engine power plant at Karbochem in Newcastle (refer to the following link <a href="https://docs.srk.co.za/en/za-newcastle-gas-engine-power-plant-100-mw-ipp-project-scoping-eia">https://docs.srk.co.za/en/za-newcastle-gas-engine-power-plant-100-mw-ipp-project-scoping-eia</a> containing Final Scoping Report for details).
