PURPOSE OF THIS DOCUMENT

This Background Information Document (BID) serves as notice (in terms of regulation 41(2) published in Government Gazette No. R327 under Section 24(5) of the National Environmental Management Act 107 of 1998) of the intent to increase the storage capacity of the existing Easigas Liquid Petroleum Gas (LPG) storage facility located in the Sidwell industrial area of Gqeberha.

This document will provide you with a brief description of the proposed project and the Basic Assessment (BA) Process that will be followed, as well as give you the opportunity to:

- Register as an Interested and Affected Party (IAP¹); and
- Provide initial comments on any environmental, social, and economic issue relating to the proposed development.

During the BA Process which will be followed, issues of concern and potential environmental and social impacts will be evaluated. Your comments will ensure that relevant issues are evaluated and will form part of the BA.

Your comments must reach SRK Consulting by **17h00** on **11 November 2021**, to ensure that they will be included and addressed in the Draft Basic Assessment Report (BAR). You may however, request to be registered as an IAP at any time during the BA process.

DESCRIPTION OF THE PROJECT

Easigas (Pty) Ltd proposes to double their current LPG storage capacity at their existing facility through the addition of a 400 m³ above ground LPG storage tank, to meet increasing LPG demand within the region and ensure security of supply for existing consumers. The facility is located on a brownfields site in the Sidwell/ New Brighton industrial area of Gqeberha and functions as a depot for collection and delivery of LPG by trucks. The current storage capacity on-site is approximately 400 m³ and the proposed expansion would result in total onsite storage capacity of approximately 800 m³.

Please note that more detailed information regarding the proposed project will be made available in the Draft BAR which will be available for public inspection and comment in due course. Only registered IAPs will be notified of its availability.

Who is doing the Basic Assessment?

In terms of the Environmental Impact Assessment (EIA) Regulations, an independent Environmental Assessment Practitioner must be appointed to conduct the Basic Assessment. SRK Consulting has been appointed to conduct the Basic Assessment. SRK will identify and assess the potential environmental impacts associated with the proposed activity by conducting an objective and independent Basic Assessment in which all the relevant information and opinions of Interested and Affected Parties (IAPs) will be collected and passed on to the competent authority (Department of Economic Affairs, Environment and Tourism). In this way an informed decisionmaking process can take place.

LEGAL REQUIREMENTS

The Basic Assessment (BA) process for this assessment will be conducted in terms of the National Environmental Management Act (Act 107 of 1998) (NEMA) 2014 EIA Regulations, as amended (GNR 326, of 07 April 2017).

The NEMA 2014 EIA regulations (as amended) list activities that may have a significant impact on the environment, and which consequently require environmental authorisation from the relevant competent authority. In this instance, the competent authority is the Eastern Cape Department of Economic Development, Environmental Affairs & Tourism (DEDEAT). The regulations further specify the assessment process, and the information that is required to enable the competent authority to make a decision regarding the activity.

The main NEMA listed activity associated with the proposed project, calling for a BA process, is the following:

• GNR 327 (Listing Notice 1) Item 51: The expansion and related operation of facilities for the storage, or storage and handling, of a dangerous good, where the capacity of such storage facility will be expanded by more than 80 cubic metres.

WHAT IS A BASIC ASSESSMENT?

A Basic Assessment (BA) is a planning and decisionmaking tool used to identify the environmental and social consequences of a proposed project, before the development takes place.

The purpose of the BA is to describe the potential consequences of the proposed development in environmental, economic, and social terms. Public issues and concerns must therefore be identified timeously so that these can be recorded and responded to in the BA. All comments received in writing are included in the submission to DEDEAT for their consideration.

During the BA Process, a Draft Basic Assessment Report (BAR) will be released. Once the public and authorities have had adequate opportunity to review the Draft report and submit comments on its content, a Final BAR will be submitted to DEDEAT for a decision.

PUBLIC PARTICIPATION

Public participation is the cornerstone of the Environmental Impact Assessment process. The principles of NEMA govern most aspects of Basic Assessments, including public participation. These include the ongoing provision of sufficient information (in a transparent manner) to Interested and Affected Parties (IAPs).

During the Public Participation Process, input from the proponent, technical experts, government authorities and the general public will be gathered to result in a better understanding of the project for all involved, and more informed decision-making throughout the process.

IAPs will be given the opportunity to comment on the findings of the Draft BAR and findings of any Specialist studies during the specified comment period.

BASIC ASSESSMENT PROCESS




Figure 1: The BA Process

A flow diagram illustrating the main activities involved in the BA process, and the legislated timeframes for each, as well as commenting periods, is provided in Figure 1.
